





## General Information

#### Admission procedure

Applications are to be made in the specified Application form which can be collected during the specified dates from the School's Office.

The dates for the form will be notified on the school's website and also on the notice board of the school. Interested parents are requested to check.

The dates for the admission test will be notified on the School notice board, as well as on the website. Candidates are requested to appear for the admission test along with a copy of the admit slip ( attached with the form ).

The names of short listed candidates will be communicated to the parent / guardian and displayed on the notice board as well.

The short listed candidates and their parents / guardians are required to attend an interaction with the Principal along with the following documents:

- 1. Filled up form
- 2. Attested photocopies of the Birth Certificate (2 copies)
- 3. Original Birth Certificate
- 4. Report Card of the previous class ( in case of candidates seeking admission to Grade II or above )

The selected candidates will have to submit the Admission Form along with the fees at the school office on the scheduled dates.

#### Withdrawal

A prior notice is a must in case of withdrawal of a student from the school. A pupil failing in the same class, two years in succession is automatically considered withdrawn and the name is struck off the rolls. Immediate notification is required for a failed pupil who desires to continue studying the same class. A student absent from school, without prior notice for a considerable length of time may not be retained in school. Irregular attendance, behavioural problems or any kind of ill influence attempted to be created might lead to removal of a student from the school.

## Ground Plan

School is regarded as the 'Knowledge House' and precisely so for the young kids where they respond to elementary shapes clubbed with vibrant colors.



Our concept for the school interiors emerges from the five basic elements of the Panchamahabhutas -

A - Akash (Space)

B-Vayu (Air)

C-Jal (Water)

D-Prithvi (Earth)

E-Agni (Fire)

and further we have incorporated educational elements in different rooms.

Universally, the five elements are mixed in an infinite variety of relative proportions such that each element is distinctly unique. All though each element has a range of attributes, they maintain their presence felt at all times. Constantly changing and interacting with each other, they create a situation of dynamic flux that keeps the world going.

These elements reflect in every aspect of our life and the same are depicted through pictorial representation on the school floors. The lobby area is exclusively demarcated into five distinct zones, each zone representing these five elements. The distinct character of every element would catch attention of the child entering the school on a daily basis and the deep rooted philosophy behind these five elements would be subtly absorbed by the youngsters. This specialized themed flooring would stimulate the child's intrinsic brain and help develop a learning curve towards nature in general.





